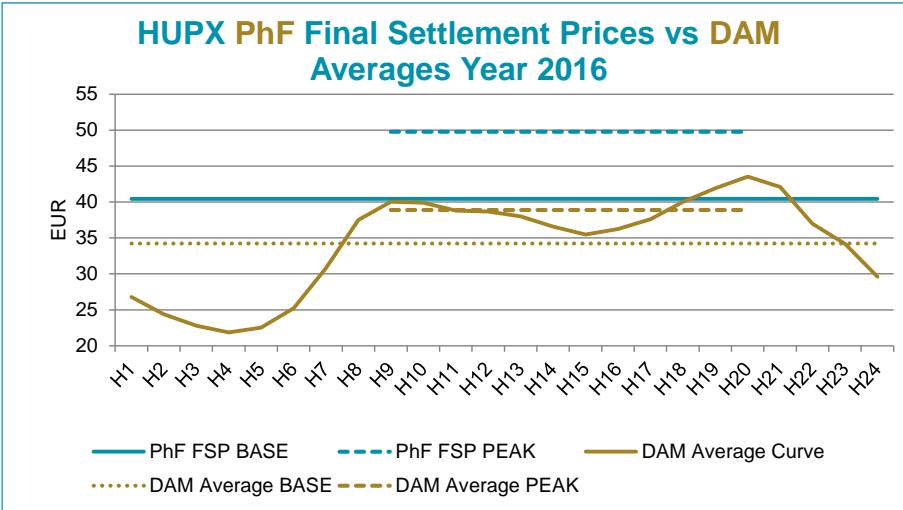
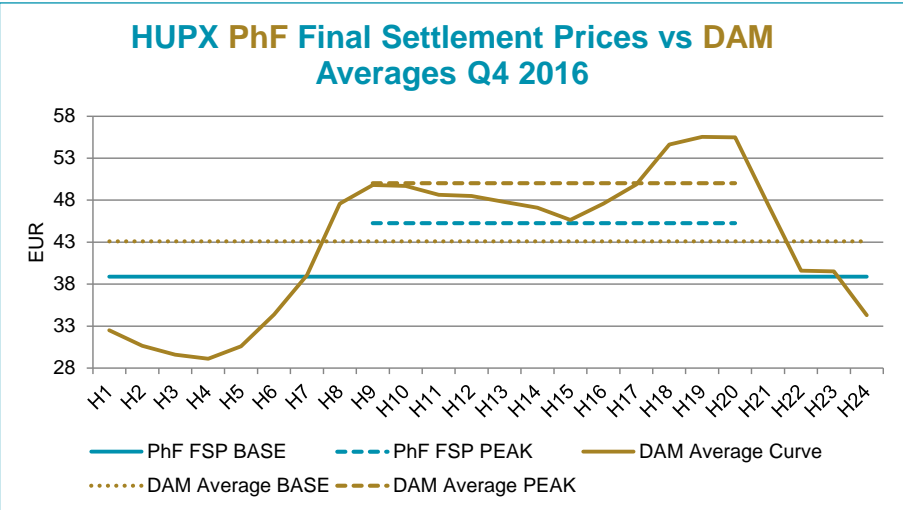
Average Price Difference and Final Settlement Prices



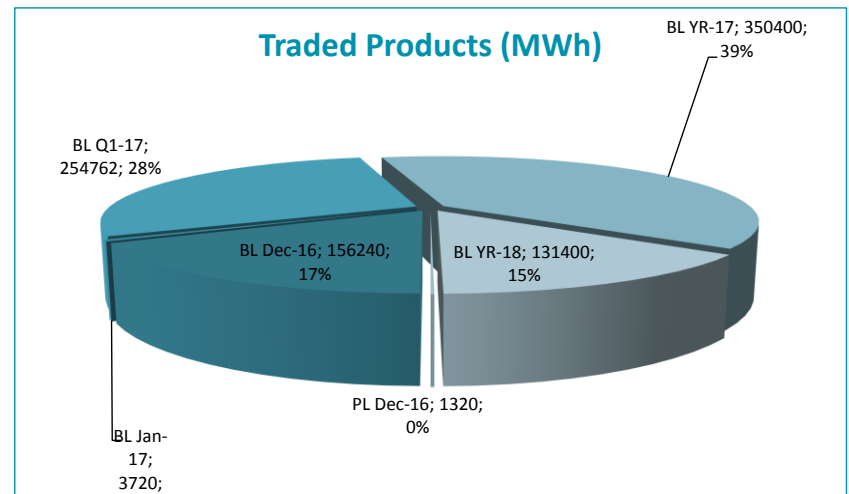
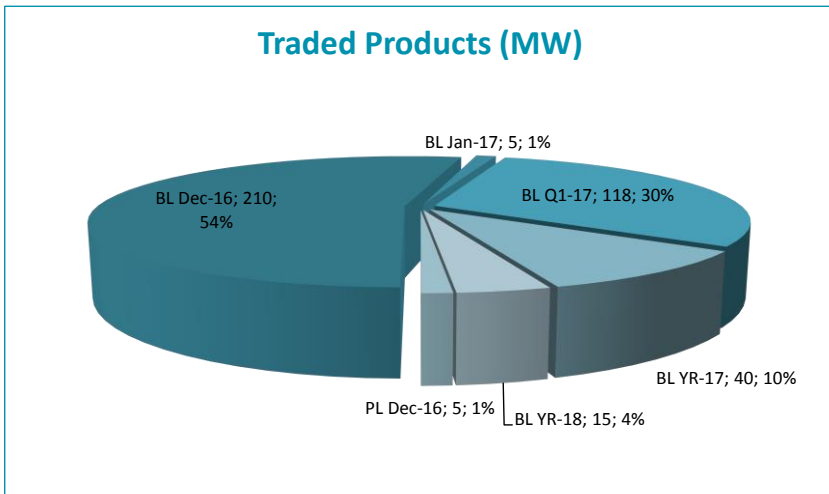
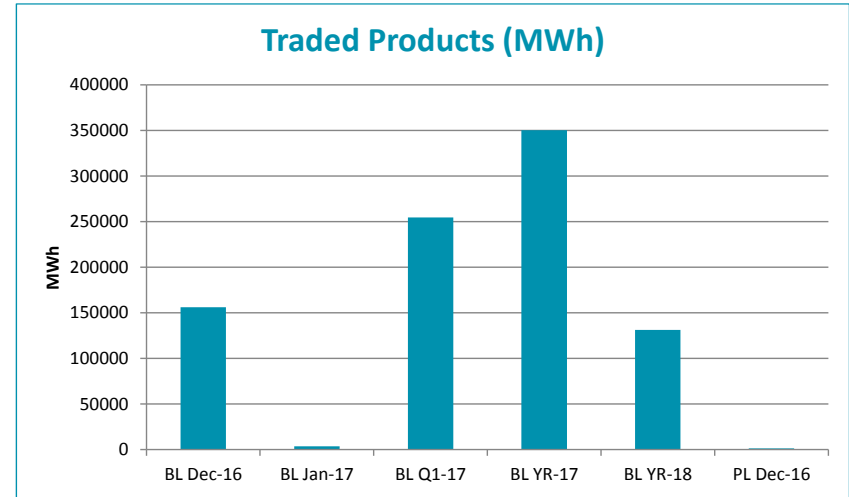
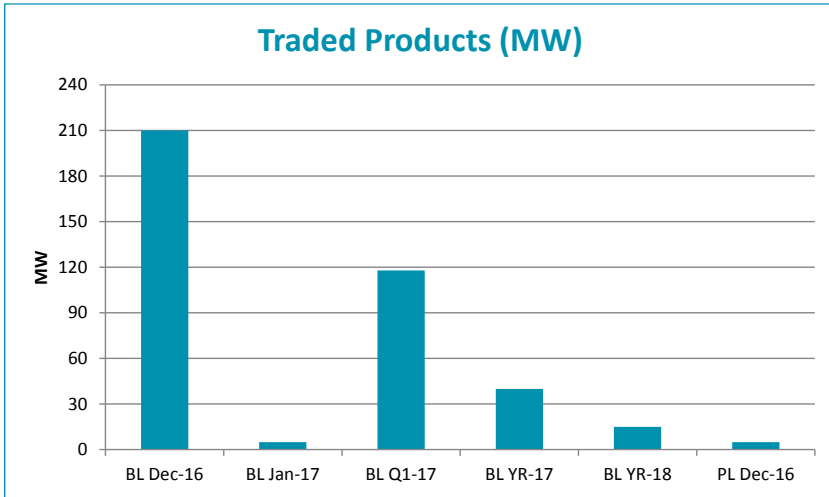

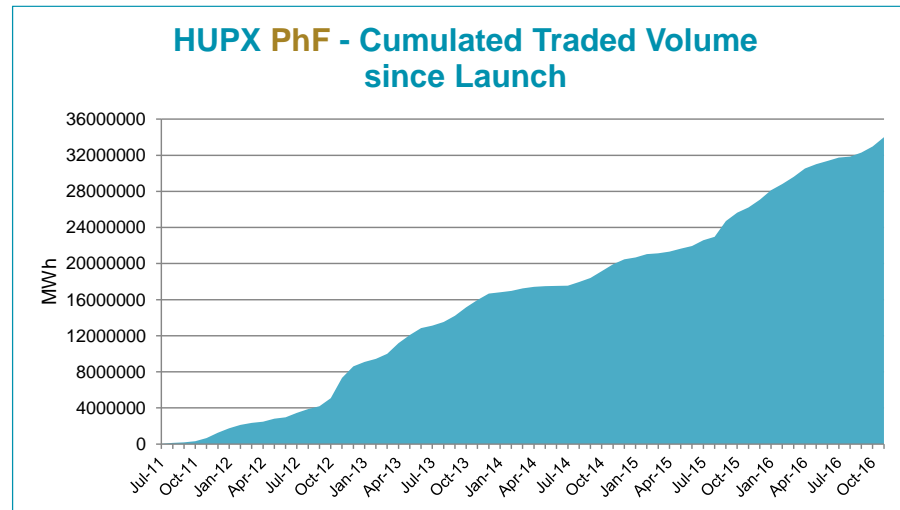
