6. **Who has the right to get acquainted with the data?** Executive officers, employees of HUDEX and its subcontractors and performance agents involved in the operation of the HUDEX Markets. The HUDEX Member authorizes HUDEX Derivative Energy Exchange Ltd. to communicate the information returned to the following data processors and recipients:
- to its relevant service providers,
  - to the lawful authorities that would ask for them including the financial supervisory authorities and tax authorities.

7. **Rights in connection with data processing**

The affected person may request information about the handling of his/her personal data and may request to correct and (except for statutory data handling) to cancel or withhold his/her personal data.

At the request of the affected person the data controller is obliged to provide information about the personal data handled by itself or by the data processor mandated by the data controller.

The data controller shall also provide information about the sources of the personal data, the purpose, legal ground and period of data handling, the name and address of the data processor and the acts of the latter in connection with data handling, and (in case of transmission of personal data) about the legal ground of transmission and the recipients.

The data controller is obliged to provide clear information in writing in the shortest possible time period after the receipt of the request, but not later than in 30 days.

If the data controller refuses to provide information or does not fulfil the request of the affected person to correct, withhold or cancel the personal data, it shall inform the affected person on the factual and legal reasons of the refusal in writing within 30 days. In such a case the data controller shall also inform the affected person about the legal remedies and the possible proceedings before the Hungarian National Authority for Data Protection and Freedom of Information. The data controller notes that the trading on HUDEX cannot be performed in the absence of certain data.

8. **Legal remedies in connection with data handling**

In case of unlawful data handling the affected person may initiate proceedings before the Hungarian National Authority for Data Protection and Freedom of Information (registered seat: 22 / c Erzsébet Szilágyi fasor, Budapest 1125, postal address: 5 P.O. box, Budapest 1530, phone: +36 (1) 391-1400, e-mail: [ugyfelszolgalat@naih.hu](mailto:ugyfelszolgalat@naih.hu)) or initiate litigation before the county court (in the capital: Municipal Court). According to the choice of the affected person the lawsuit may be brought before the county court competent according to the permanent or temporary residence of the affected person. If the court finds that the request is justified, the court obliges the data controller to correct, withhold or cancel the personal data, or to take into consideration the affected person's objection.
